- "EU heads of states agreed in February to launch the €6 billion Youth Employment Initiative, with the aim of making it fully operational by 1 January 2014"
  - €1.3 million in assistance to set up apprenticeship schemes
  - EU countries can claim their part of 4-billion-euro pie to set up Youth Guarantee

- Scoreboard would become part of Union's employment report which is published each fall featuring five main indicators:
  - unemployment, youth unemployment, household disposable income, the at-riskof-poverty rate, and inequality
