- CSRs will only increase distance between institutions of EU and citizens they are meant to serve
- 'Less is more' approach is concerning (targeting fewer areas, with more specificity)
- Long term ways to get young people out of crisis are ignored by latest CSRs
- Lack of ambitious strategies for member states to ensure more quality jobs only some references to health, social inclusion, poverty, education, but are not part of plan for better jobs
- Commission fails to identify main reason for youth unemployment
- Recommendations highlight need for more flexibility in terms of differentiated wages and labour laws their rational: France for example, could "provide more incentives for employers to hire on open-ended contracts
 - Ignores that deregulatory approach to labour markets is risky in terms of number of quality jobs that can be created
 - Could turn existing jobs into precarious jobs, without creating new ones
- Only 6 countries received recommendations on poverty and social inclusion even though EU is far from their goals on poverty reduction
- EUROSEMs focus on key areas brings EU further away from citizens
 - Less influence of young people when areas of contention are so few
