- "Not even the much-vaunted European Semester has achieved any real impact. Only ten of its 157 main recommendations in 2014 were fully implemented or showed substantial progress (a success rate of 6.5%)"
- Response rate to EUROSEM is same as the response rate to purely voluntary OECD recommendations
- All of this low implementation gives perception that EU is just a big "think-tank"
- How can European citizens believe in a project that cannot even enforce its own rules?
