Building on my dissertation work, my research focuses on social and structural inequities experienced by underserved populations, including groups negatively affected by displacement, for example, refugees and other groups that experience displacement and structural vulnerabilities due to war, environmental change, and political persecution. I examine how age, sex/gender, ethnicity/race, class/poverty, and other social identity categories shape and are shaped by structural determinants of mental health. I use critical qualitative and theoretical approaches such as gender-based analysis (GBA), intersectionality, and arts-based methods such as photovoice, film, and video. These approaches seek to disrupt dominant narratives that structure and position marginalized groups as inferior and a threat to Canadian society. These methods and theories assist me in promoting social justice as a central component of my research. I incorporate these approaches to promote better integrated, culturally safe, and equitable health care systems and services.
